Migrant and Seasonal Agricultural Worker Protection Act	Applies to seasonal and migrant farm workers	
Employee Rights under the Davis-Bacon Act	Applies to federally funded construction projects	
Employee Rights on Government Contracts	Applies to specific types of federal government contracts.	
Employee Rights under the National Labor Relations Act	Applies to federal contractors and subcontractors.	
Workers with Disabilities Paid at Special Minimum Wage	Applies to organizations operating special programs that pay disabled employees less than the federal minimum wage.	
Check Your Withholding (IRS)	This poster is "recommended" but not legally required.	
Payday Notice	This poster is "recommended" but not legally required in MN.	
A Guide to Minnesota's Laws about Parental Leave	This poster is "recommended" but not legally required.	
No Smoking (MN Clean Indoor Air Act)	Required by law, but not an employment law poster. (To be posted inside building entrance.)
